The under graduate degree offers three years of course work and one year of Student READY Programme (Rural Agricultural Work Experience, In-Plant training and Experiential learning Porgramme) with an intake capacity of 32. The major disciplines of Community Science are Food and Nutrition, Apparel and Textile Science, Resource Management and Consumer Science, Human Development and Family Studies and Extension Education and Communication Management. The courses curriculum of agriculture, animal husbandry, forestry, fishery science, agricultural engineering are also added for enhancement over and above where as course curriculum of Community Science is based on utilization of all farm produces in scientific and judicious way so that every individual will lead healthy life. Much emphasis has been given to empower farm women technologically, socially and economically utilizing human resources of community science. The students are competent enough to



improve the food and nutrition security of farm families, providing livelihood security and comfort provider to the farm women, reducing malnutrition from the rural community and above all they will act as an expert of rural development of the state.
