Back ground:
Bejha farmer producer company limited is the brain child of Mr Ram Nandan Prasad, Masters in mathematic with gold medal. He was started farming in his village gunnipur bejha after completion of his educatio with the aims to works with innovative approach and cooperation provide to small and marginal farmers for betterment of socio economic conditions residing more than 1000 farm families in the village with scarify jo mentality which is most common amongst the students. As Mr. Prasad reported that till January 2025 no an assistance received from NABARD and others funding agencies under FPO scheme. This village is situated a more than five kilometres from NH 28 Sujawalpur choke and about 7 kilometers from Dholi Railway station The block head quarter is at the distance of about 6 kilometers and Panchyat bhawan about 2.8 kilometers



This village is surrounded by Muraul block toward north, Patepur block towards south , Chehrakala block toward west and Bandra block toward north. The nearest cities to village is Muzaffarpur, Samastipur, Vaishali, Kanti, Lalganj. This village is in the border of Muzaffarpur and Vaishali district. Two most important rivers namely Burhi gandak and bagmati flows near to the village. The financial institutions like Bank of India, HDFC Bank, State Bank, Punjab national bank exists in the locality. This company is working on natural farming and raising more than 35 deshi cows, so many fruit trees like lemon seedless, apple, angeer, guava, also maintaining in his own farm, preparation of organic inputs, goober cakes and diya for puja purpose, a small tank also situated in the farm and integrate with vegetables enterprises, fish enterprises, dairy enterprises, fruits enterprises, spices enterprises, etc. In the farm solar systems also functioning and use for multipurpose works. Up to December 2024 more than 500 farmers directly and indirectly benefited from the company in the form of services, inputs, output sales, etc.

# Focus area:

Natural farming and preparation of natural inputs, supply natural products and inputs to the non members and consumers, deshi cow rearing, Provide fresh milk in glass bottle, ghee and vegetables to the consumers demanding from Apartments of Patna which is just 65 kilo meters far from this company. In long run value addition and processing of fig (Anjeer) will be started by the company. Assembling of vegetables and searching better markets in outside the village is also plan kept in mind.

Education, innovation and hard work will be essential for achieving the set goals with collective approach for any kind of business. More than Rs 2.2 crores this farmer producer company done total business within the year of establishment and benefiting 250members farmers and 300 non member farmers were benefitted. # Way forward:

The FPC going forward to diversify into value added products and set up milk processing unit with the assistance of either government or privately.
